

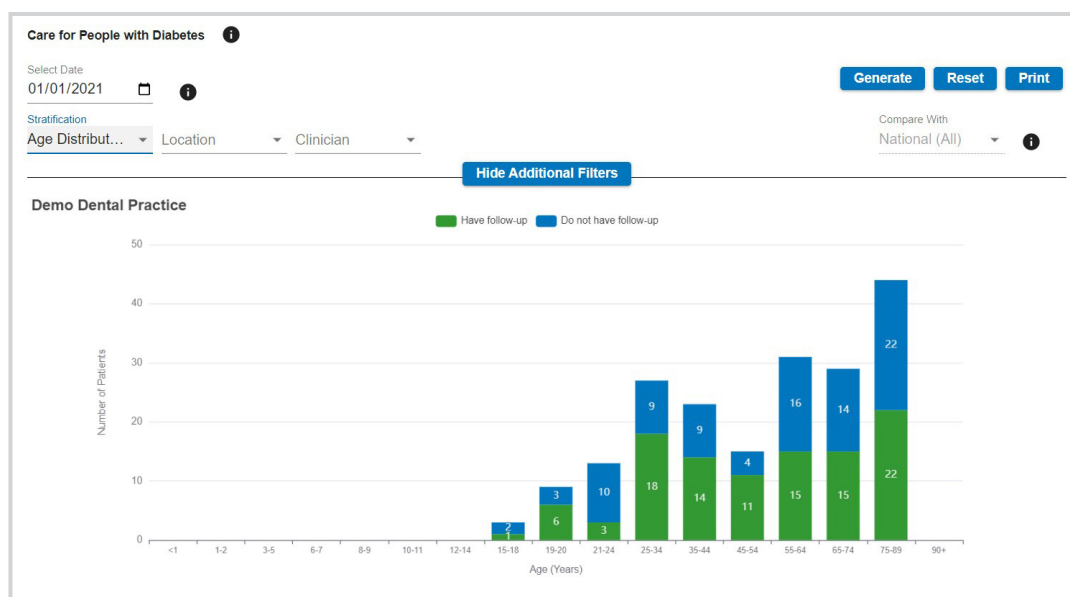
Meet the DERE™ Dashboard

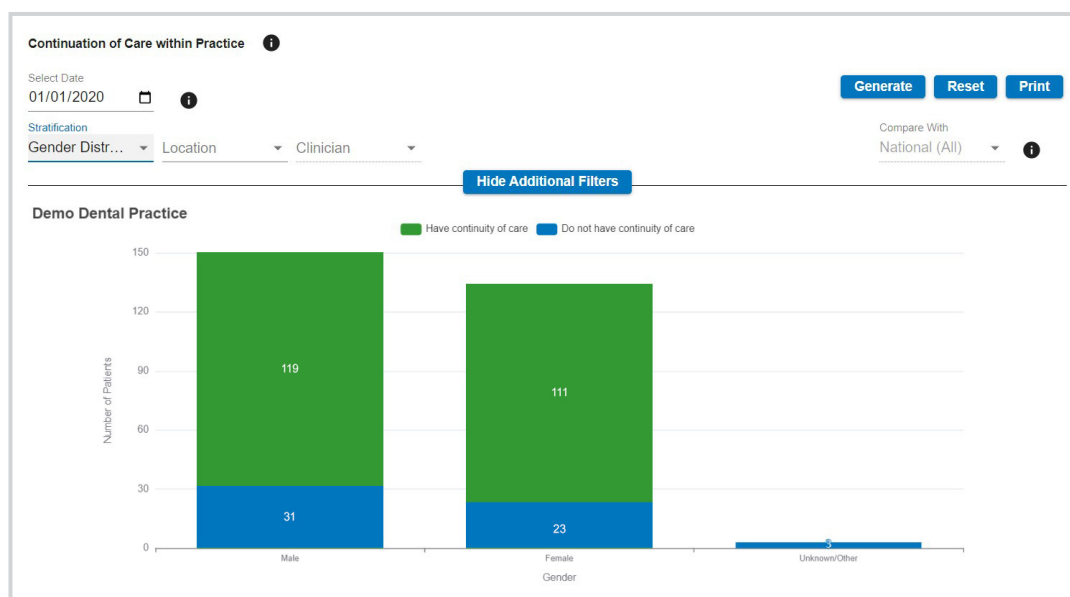

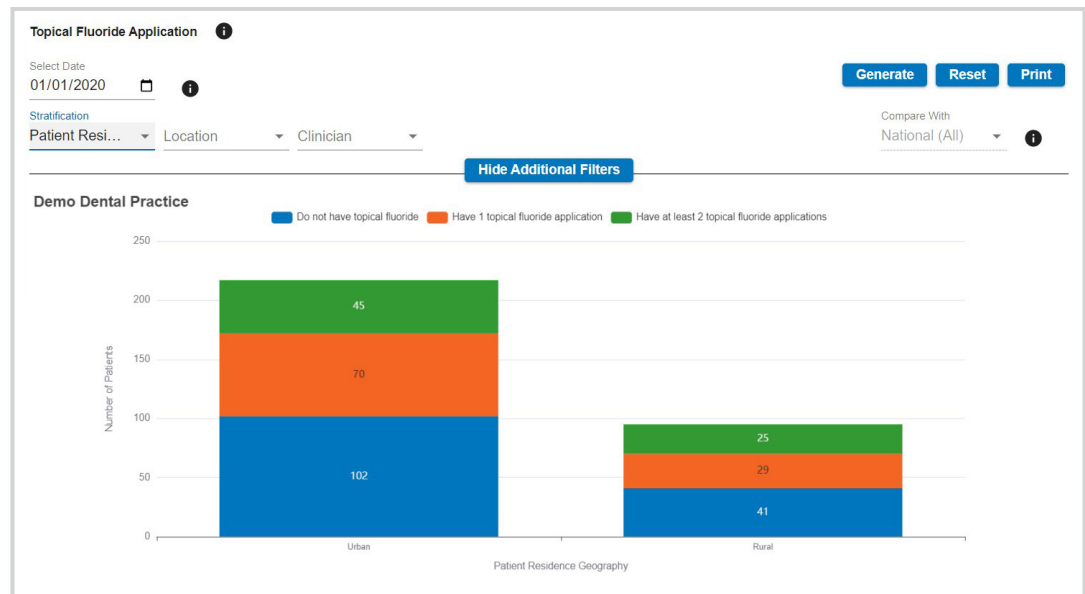
