Insight: As of the week of September 7th, nearly 99% of dental practices in the U.S. were open. This has remained largely unchanged over the past month.

DSO-affiliated and group practices are more likely to report "business as usual" *in terms of patient* volume.


Open and business as usual Open but lower patient volume than usual

Insight: Nationally, patient volume is leveling off. Patient volume in dental practices is estimated at 74 - 81% of pre-COVID-19 levels as of the week of September 7th.

Insight: Staffing in dental practices is stabilizing and is at 94% of pre-COVID-19 levels the week of September 7th.



Insight: Employee dentists have seen the biggest lingering employment effect. Less than 80% of employee dentists were being paid fully as of the week of September 7th.

For those not being paid at all, about one-third were receiving unemployment benefits.

Insight: BLS data show employment in dental offices in August was at 96% of pre-COVID-19 levels, in line with data from HPI's survey.

How many days' worth of the following PPE does your practice have at this time?



Insight: PPE availability in dental practices has been stable over the past month. Gowns and N95/KN95 masks remain the biggest issue, as well as disinfecting supplies.




Have you applied for funds from any of the following relief programs? (Check all that apply.)



Insight: About 93% of dentists applied for some form of financial relief. The most popular programs have been the PPP, the HHS Provider Relief Fund and the Economic Injury Disaster Loan.

Dentists in solo and small group practices were more likely to apply for these programs than dentists in large group practices.







Insight: Medicaid providers were slightly more likely to apply for the HHS Provider Relief Fund.

[If applied] What is the current status of your relief program application?




Why have you not applied to the HHS Provider Relief Fund? (Check all that apply.)



Insight: Among dentists who did not apply for the HHS Provider Relief Fund, the most common reasons were that they did not think they qualified or did not know about the program. All practicing dentists are eligible.






Insight: Non-Medicaid providers were more likely to report that they did not know about or thought they did not qualify for the HHS Provider Relief Fund.

Medicaid providers were more likely to indicate that the amount was too small and the application process was too complicated.

Insight: About two-thirds of dentists think it is extremely or very important to have rapid, point-of-care COVID-19 testing for their team and themselves. The availability of testing for patients in the office was of slightly lesser *importance.*

Dental team members?




Insight: Dentists who are affiliated with a DSO, practice in large groups, or are older believe it is more important to have rapid, point-of-care COVID-19 testing available.

Assuming that dentists in your state were permitted to do so, would you be willing to administer COVID-19 vaccines to patients in your office? ALL RESPONDENTS




Insight: Less than half of dentist would be willing to administer COVID-19 vaccines to patients in their offices. Dentists in large group practices were more willing.

Insight: Periodontists and oral surgeons are the most willing to administer vaccines in their practices. Prosthodontists and endodontists are the least willing.

- How do employers and employees navigate a workplace return?







Which of the following conditions is closest to your current point of view... Visit a dentist's office





Key Take-Aways from September 7th Data

- Recovery: As of the week of September 7th, 99% of dental offices in the U.S. were open and patient volume was estimated at 74 81% of pre-COVID-19 levels. Staffing was at 94% of pre-COVID-19 levels. These values have been roughly unchanged over the past month and suggest we are reaching a "steady state" of economic activity in dental offices.
- **Financial Relief:** Over 90% of dentists have applied for financial relief, most commonly the Paycheck Protection Program, HHS Provider Relief Fund, and Economic Injury Disaster Loan. The vast majority received funds. Among those who did not apply for the HHS Provider Relief Fund, the most common reasons were not knowing about it or believing they were ineligible.
- **Testing:** About two-thirds of dentists think it is important to have rapid, point-of-care COVID-19 testing for their team and themselves. Roughly half believe the same for patients in the office. There is variation by DSO affiliation, practice size, and dentist age. Dentists in public health settings placed more importance on testing than dentists in private practice.
- Vaccination: Less than half of dentists polled would be willing to administer COVID-19 vaccines to patients in their offices. About a third would "maybe" consider it, while 25% are unwilling. There was some variation by practice size, with dentists in large group practices more willing. Dentists in public health settings were more willing to administer COVID-19 vaccines than dentists in private practice.
- **Consumer Sentiment:** About 15% of patients will not return to the dentist until a vaccine or proven treatment is available. The public, at least currently, do not rank dental offices high as locations they would be willing to get a COVID-19 vaccine.
