

**National Board Dental Hygiene Examination
Released Items Order Form**

Released Item Sets: The Joint Commission on National Dental Examinations (JCNDE) released National Board Dental Hygiene Examination (NBDHE) items that were administered from approximately 2000 to 2008. The items were released in two editions: 2006 and 2009. The materials have been released to familiarize candidates with the format of the examination and the types of case materials and items that have appeared on the NBDHE in recent years.

Pilot Examination: In 1996, the JCNDE administered a pilot examination of the revised case-based NBDHE format. The revised format emphasizes patient problems and assesses the abilities of candidates to use their knowledge of dental hygiene. A series of patient cases are presented, and each case is followed by multiple-choice questions pertaining to the case.
