It is important to select a reputable recycler that complies with applicable federal and state law, and provides adequate indemnification for its acts and omissions.

### Some Questions You May Wish to Ask Your Recycler ...

- What kind of waste do you accept?
- Do your services include pick up of waste from dental offices? If not, can waste be shipped to you?
- Do you provide packaging for storage, pick up or shipping of waste?
- If packaging is not provided, how should the waste be packaged?
- What types of waste can be packaged together?
- Do your procedures comply with ANSI/ADA Specification 109: Procedures for Storing Dental Amalgam Waste and Requirements for Amalgam Waste Storage/Shipment Containers?<sup>1</sup>
- Does your company have an EPA or applicable state license?
- Does the company use the proper forms required by the EPA and state agencies?
- How much do your services cost?
- Do you accept whole filters from the vacuum pump for recycling?
- Do you pay for clean non-contact amalgam (scrap)?
- Do you accept extracted teeth with amalgam restorations?
- Is disinfection required for amalgam waste?
