I am currently enrolled in the Louisiana State University, Shreveport, MBA program (completion 03/2024). I am proficient with excel, R and Quickbooks.

At the Georgia Dental Association, I have been on the Finance, Benefits & Audit committee 2010-2014 & 2018-present. I have been its chair since 2022. I have worked along side the Executive Director and CFO analyzing the internal forecasting and finalizing the budget. The process employed is mission based. I am also involved in the analysis of contracts for endorsed partners and their financial impacts. In this role I report to the Board of trustees, the House of Delegates and to the membership at large.

I have been Treasurer of the NWDDS, setting the preliminary budget & forecasting then finalizing the budget with the district executive committee. Responsible for A/P, A/R, reconciliation and quarterly reporting.

I have also been on the Georgia Wing of the Civil Air Patrol Cobb County Composite Squadron's finance committee setting forecasts and budgets. Additionally I was an Incident Commander and Director of Operations for Group 1. This role impacted 6 squadrons, 5 aircraft, 10 vehicles and about 125 volunteers. Again setting, at the mission level, budgets, expense tracking, reconciliations and reporting to Georgia Wing Command and the United States Air Force Liaison office.

I have also owned Kennestone Periodontics, a multi-location, privately held specialty dental group. Over time we had up to 5 Periodontists, 8 Hygienists and 20 support staff over 4 locations. I prepared the forecasting, marketing, budgets and monthly finance reports. I reported to the equity partners.

Describe your experience with the ADA budget process and finances, including any experience gained from serving as a delegate, trustee, council member or similar service.

I have been a Delegate or Alternate Delegate to the ADA House of Delegates since 2017. During that time I have been interested in the finances of the ADA. I have chaired the Georgia delegation and have chaired the Reference committee A workgroup in the 5th TD. I have seen how the budget has been presented to the house, I have met many times with the ADA CFO and have met with the ADA finance department as part of the Georgia dental association. I have become familiar with the account reporting process and can visualize the cashflows within the ADA. Moving forward, the Board of Trustees will have the budget and the process will be managed through the Strategic Forecasting Committee. I will discuss my opinion on this later on in this document. However, in short, the traditional finance methodology has changed, and the House has yet to see the impact.

As a member of the Advisory Committee on Annual Meetings (CAM), I have served as a general member, Continuing Education Chair (2022) and General Chair (2024). I have also been the liaison to the Sponsorship and Exhibit departments. Overall, the annual meeting budget is closely held by ADA staff and little information is given to the volunteers. The only budget item the volunteers have control over are the admission prices meeting attendees pay to attend the meeting. As a CAM member, we are only given "big bucket" revenue and expense numbers. As meeting chair, I am extremely aware of budget needs and have worked closely with ADA employees and our Board representatives. I am aware that mission based accounting is in play with the SFC and that the annual meeting budget is to be set by 01/2024. I am also aware of the structure of the Annual Meeting ADA team, their budget process and their reporting process. Lastly I am aware of the financial position of SmileCon based on revenue, sponsorships, exhibits, and expenses.

Explain how you plan to assist in interpreting Association finances and effectively share financial information with the House of Delegates and membership.

My personal strength has been the ability to look at a complex process, analyze its components and be able to easily explain the process at a level understandable by whatever stakeholder I am reporting to. In the Civil Air Patrol this ranged from maintenance people, search crews, Wing Command and the Air Force liaison officer. In my roles within the Georgia Dental Association and its tripartite components, I have been able to communicate the position of the organization at any time.

Be it through osmosis sitting on various finance positions at the GDA and NWDDS since 2010, mentoring by the former GDA CFO and former Executive Director, and via my formal education during the MBA, I have developed a tactical sense of finances. I have had a front row seat in where the GDA went from near insolvency to financial stability with investments of its excess revenue.

What matters is not where a financial position may be, but rather the WHY a financial position exists. Pages of financial reports marginalize individuals and don't adequately inform them of the ADA's financial health. My role of treasurer towards the ADA membership would be to tell the story of our finances, strategy, outcomes and reactions. This would improve engagement by our members and improve their situational awareness.

What experience in dental association service, dental practice, dental education or private business would qualify you to serve as treasurer of the American Dental Association? What special skills or knowledge do you offer? (250 words or less)

Through the course of my financial involvement in the Georgia Dental Association, the Northwestern District Dental Association, multi-location group practices and the Civil Air Patrol I have worked closely with the various individuals which make up a team. I have worked in decision making roles with owners, vendors, customers, accountants, comptroller's, CFO's, attorneys, consultants, IT designers and implementors and many other professionals who touch the finances of enterprises, corporations, the military and the government. Each of these interactions were learning experiences. I went from the proverbial student, understudy to colleague. Forecasting, budgeting, reporting (balance sheets, income statements, cash flow statements, shareholder equity statements), policy making, meeting with stakeholders, contracting are familiar processes.
